The Anguilla Financial Services Commission (AFSC) invites quotations from suitably qualified and experienced audit firms to undertake the external audit of its financial statements for the specified financial period(s). SCOPE OF SERVICES

The selected audit firm will be required to perform the annual audit in accordance with International Standards on Auditing (ISA) and to issue an independent auditor's report on the financial statements of the AFSC.

KEY DELIVERABLES

The successful audit firm will be required to provide the following deliverables:

1. Draft audited financial statements and draft audit opinion;
2. Final audited financial statements;
3. Independent auditor's report;
4. Management letter outlining audit findings and recommendations; and
5. Presentation of audit findings to the Members of the Board.



MINIMUM QUALIFICATIONS AND EXPERIENCE

Audit firms must submit:

1. Firm profile and background as well as proposed engagement partner and team details, including qualifications and experience;
2. Relevant audit experience with financial institutions, statutory bodies and regulatory authorities, plus at least two references from similar engagements;
3. Brief audit methodology and approach and financial quotation, including all foreseeable expenses;
4. Signed declaration confirming no actual or apparent conflict of interest, independence of the bidder, engagement partner and audit team, compliance with applicable professional standards, and disclosure of any prior or current services, relationships or circumstances that may affect, or appear to affect, independence.
